3. This Release shall extend to all liability, claims, causes of action, or demands known or unknown, foreseen or unforeseen, at the time of signing of this agreement. This release shall extend to all unknown and unforeseen claims, causes of action, demands and to all unknown hazards as set forth in Code of Civil Procedure Section 1542.

The undersigned covenants hat he/she shall not now or any time in the future, directly or indirectly, commence or prosecute an action, suit or other proceeding against the Hayward Area Recreation and Park District, Rowell Ranch Rodeo, Inc., its officers, directors, employees, agents, or affiliates concerning or arising out of related to the actions, cause of actions, claims, and demands hereby waived, released or discharges by the undersigned with said covenant not to sue to extend to all unknown risks pursuant to Code of Civil Procedure, 1542.
