- **ALL VENDORS ARE REQUIRED TO PROVIDE A CERTIFICATE OF INSURANCE FOR COMPREHENSIVE GENERAL or COMPREHENSIVE PERSONAL LIABILITY** coverage naming The Rowell Ranch Pro Rodeo and Hayward Area Recreation District as additional insured. The vendor shall provide a certificate of insurance to the *Rowell Ranch Pro Rodeo* evidencing such coverage with this application.
